CALL TO ORDER

The Annual Organizational Meeting of the Corcoran Unified School District was called to order by Superintendent Rich Merlo at 6:30 p.m. in the Board Room of the Administration Office.

SWEARING IN OF BOARD MEMBERS

Superintendent Rich Merlo swore in Robert Alcorn, Mary Gonzales- Gomez and Steve White to four-year terms as members of the Board of Trustees.

ELECTION OF PRESIDENT

Mr. Merlo called for nominations for President of the Board. Steve White nominated Mary Wadsworth and Robert Alcorn seconded the motion. Karen Frey motioned to elect Mary Wadsworth president, Steve White seconded and Mrs. Wadsworth was elected president by a unanimous vote from the Board.

Karen Frey moved, Robert Alcorn seconded and on a unanimous vote, the Board elected Steve White as Vice President.

Mrs. Wadsworth called for nominations for Clerk of the Board. Robert Alcorn moved and Mary Wadsworth seconded a nomination for Karen Frey as Clerk. A motion was made by Steve White and a second by Mary Wadsworth was followed by unanimous approval from the Board electing Karen Frey as Clerk.
